Admission Requirement

Doctor of Philosophy (by Research Only)

A relevant Master's degree with good grades from the IIUM or any other accredited Institution of higher learning;

Or

Any other certificate that is recognized as equivalent to a Master's degree or other relevant professional qualifications and experience that are recognized by the Senate of the University.

And

A suitable research proposal is required for Ph.D applicants.

Research Methodology and Islamization of Knowledge courses should be classified as SPECIAL REQUIREMENT courses and carry CREDIT HOURS allocated to them. The evaluation of the courses, however, will be on a PASS or FAIL basis i.e., excluded from the CGPA calculation.

Research Monitoring and Thesis Completion

Formal monitoring and evaluation of research progress are to be carried out every semesters. Student's research progress report is to be submitted to the Kulliyyah's Research and Postgraduate Committee through *I-Monitor* for assessment and approval.

Lack of progress in research work in two consecutive periods would lead to the termination of studies. Students research works will be evaluated based on their written thesis that will be examined by both external and internal examiners. It is compulsory for PhD students to submit research findings for publication before proceeding for viva.

Application for Extension Duration of Study

Students are required to submit the following in the application for extension normal duration of study:

1. An appeal letter which states the reason(s) clearly and justifications on how the extra time can help the student to complete the research work.
2. A strong recommendation letter from the supervisor to justify how the extra time can help the student to complete the research work
3. A revised study plan in the form of Gantt Chart;
4. A list of Chapter has been written and yet to be written.

**** Appeal for extension should be submitted to the Office of Deputy Dean (Postgraduate & Research), One (1) month before the normal study period ended.*
