We will present your appeal at the Kulliyah Postgraduate Committee (KPGC) Meeting and subsequently recommend it for approval at the University Committee for Postgraduate Studies (UCPS). Both KPGC and UCPS meet monthly. The CPS will issue you the confirmation letter and register your course once the application is approved.
