CLAIM GUIDELINES

Kulliyyah of Medicine's Postgraduate Research and Bench Fees

The amount that can be applied is based on the bench and research fee structure, as shown in Table 1 for Master and PhD in Medical/Health Sciences, Table 2 for Clinical Specialist Training and Table 3 for Master and Doctor of Public Health.

Terms and Conditions

The approval of the application shall follow certain terms and conditions:

- 1. The tuition fee for the applied semester must already be paid in full, and the portion for bench and research fee already transferred to Kulliyyah of Medicine Research Trust Fund
- 2. The amount approved shall not exceed the ceiling stated in Table 1 and Table 2

The form should be filled out by the student and must be recommended by the Supervisor prior to submission. The request shall be checked by Officer-in-charge before being approved by Deputy Dean (Postgraduate).

The University Financial Procedure must be adhered to at all time.

A) Conference/Workshops/short courses/Research attachment/exchange programme/Mobility

- 1. The total amount claimable for conferences shall not exceed RM3000 throughout the student's study period.
- 2. The claim must be used to attend and present in a conference—either as a poster, in non-indexed proceedings, or in indexed proceedings—to fulfil the Publication Equivalent (PE) requirement (Reference: Postgraduate Regulation (Revised 2022) Item 37.1 vii: Graduation Requirement), please see APPENDIX A, OR to fulfil any other research requirement set by respective department.
- 3. Flight ticket, accommodation and car mileage must adhere to the maximum allowable claim following the guidelines for IIUM staff. *Reference: IIUM Travelling Claim: Gred/Kategori Pegawai Untuk Tuntutan Elaun, Kemudahan dan Bayaran).* Please see APPENDIX B.
- 4. For Clinical Specialist Training students, this is not applicable for IIUM workshops such as GCP, IOHK, Research Methodology and Biostatistics.

B) Fieldwork expenses

- 1. Students may claim for:
 - a. Travel and accommodation for data collection for international/East Malaysia will be reviewed on case-to-case basis.
 - b. Honorarium for study participants. (Please use the Acknowledgement Receipt)
 - c. Services related to research (such as Translation, Proofreading).

C) Publication in Journals

- 1. Students may claim up to RM 5000 for publication in indexed journals (WOS/SCOPUS/MyCite).
- 2. Priority shall be given to claims that fulfil the student's Publication Equivalent (PE) requirement.

D) Research Materials, Tools and Subscriptions

- 1. Students may claim:
 - a. Software licenses (nVivo, SPSS). Any other software will be reviewed on a case-to-case basis.
 - b. Any lab related equipment/reagents/materials.
 - c. Printed materials (for example poster, questionnaire).

Students may not claim for the following purposes:

- 1. Hardbound thesis binding.
- 2. Thesis formatting.
- 3. Statistics/Analysis services.
- 4. Arabic abstract verification.
- 5. Assets such as printer, laptop, tape recorder etc.
- 6. Membership fees for professional societies.
- 7. Collaborative project meetings.
- 8. Books/e-Books/book or journal subscriptions.
- 9. Wifi/Unifi/Online platform (such as Zoom)/AI subscriptions.

Note: Any other type of claim will be reviewed on case-to-case basis.
